**Financial Statements**

## **New Business**

**County Reports:** Kings County Director Richard MacAulay reported that there are no issues in Kings County. Queens County Director Wayne Schleyer reported that there are no issues in Queens County but took the opportunity to commend the members for the great attendance at Ian Oland’s funeral and extended special thanks to Llew Robinson and Fred Foster for their care for Ian during the latter years of his illness. Ron Allan reported that there were no issues on Prince County and informed the membership of the lunch that is scheduled for noon on October 16, 2018 at the Silver Fox Club in Summerside. The venue will provide a special menu for the event and the secretary will distribute it to the membership when it becomes available.

**Police and Peace Officers Memorial Service:** The president reported that he was initially very disappointed with the response to his message requesting attendees for the event but he now has commitments from 29 RCMP veterans, 12 from the Atlantic Police Academy, 12 from Summerside PD, 2 from Kensington PD, 1 each from Parks Canada and the Department of Fisheries and Oceans, and 6 from “L” Division. He has not yet heard from Charlottetown PD. The Lieutenant Governor, the local MLA, the Minister of Justice, and the Mayor of Summerside are also attending. Most of the roles have been assigned and the order of service is the same as past services. We are having some wreath hangers manufactured and they will be paid for by the police forces. Indications are that the available revenues will cover anticipated expenses with a small surplus.

**Record of Service Cards:** There is a national initiative to issue record of service cards to those interested in having a card to identify themselves as veterans. The intent is to use file copies of digital photographs of those former members who have been photographed for building passes and to have only a “V” in the space for photos on the cards for persons who do not have such a photo on file. Catherine Nicholson of “L” Division, with the support of the CO of “L” Division, offered to take suitable photos for inclusion on the cards requested by former members now residing on PEI but received a negative response from RCMP Headquarters. The initial decision was made by the former Chief Human Resources Officer and the current CHRO declined to alter the decision. Ruby Burns recently discussed the issue with Commissioner Lucki personally who declined to make an exception for PEI in what is a national initiative.

**Volunteers for DRE Course:** The Director of the Atlantic Police Academy requested volunteer drinkers for a Drug Recognition Expert course for “H” Division personnel on September 21 and 26. Anyone interested in assisting is asked to respond directly to the

persons identified in the e-mail on the subject sent to the membership on September 18, 2018.

**Entertainment Committee:** Phil Pitts reported that there was a great turnout to the lobster dinner and it almost broke even financially. The turnout for the golf tournament was disappointing and consideration is being given to combining it with the "L" Division golf tournament next year.

**Gravesite Inspection Committee:** Damien Dunsford reported that the 2018 inspections have been completed by five inspectors with 123 grave sites in 54 graveyards being inspected. Four new grave sites were photographed and the GPS coordinates logged on the Division website. Five headstones in Queens County were identified as being in need of cleaning with all the other headstones being in good condition in well-maintained grounds.

**Military Family Resource Centre:** Richard Thibault reported that services, such as bridge passes and gas cards, are available to RCMP families who require off-Island medical treatment. The MFRC might not be able to assist in some cases but they will assist in locating an entity that can help. If you think you qualify for such assistance, call or visit the MFRC at HMCS Queen Charlotte.

**Ted Whelan Memorial Award:** The president asked that all nominations for the 2018 edition of the award be forwarded to the chair of the selection committee, Randy Robar, by October 31, 2018.

**North Shore Community Centre Fundraiser:** Llew Robinson reported that former 'Singing Mountie' and lead singer for the Blue Crystals, Andy Arsenault, has volunteered his talents to a fundraiser in aid of North Shore youth at the North Shore Community Centre on West Covehead Road, York, on October 20, 2018.
