

## **Minutes of Previous Meeting**

The secretary moved, seconded by Bob Moffatt, that the minutes of the September 18, 2018 meeting be adopted as circulated. CARRIED

### **Financial Statement**

The treasurer circulated an income statement for the fiscal period ending November 25, 2018 which showed revenues of \$8,564.00 and expenses of \$7,027.10 and an operating surplus of \$1,536.90. The treasurer reviewed each line object on the statement and moved that the statement be accepted as circulated, seconded by Don MacGregor. CARRIED

## **Business Arising From Previous Minutes**

The president provided an overview of the 2018 Police and Police Officers' Memorial Service that was held in Summerside on September 30, 2018. The event receives financial support from the PEI Police Association, the PEI Association of Chiefs of Police and the Government of PEI and generated a small surplus which has been added to the previous balance carried forward. The president noted that the event was well attended by members of the PEI Division and the Atlantic Police Academy but the attendance by serving RCMP and municipal police personnel was disappointing. The secretary noted that the issue was discussed at a recent CO's Employee Advisory Committee meeting and the lack of attendance of serving RCMP members is mainly attributable to resourcing issues. Peter Sorensen also expressed the view that resourcing issues are the main cause of the lack of attendance of serving RCMP members.

#### **New Business**

**County Reports:** Kings County Director Richard MacAulay reported that there are no issues in Kings County. Queens County Director Wayne Schleyer reported that Bob Nahrgang is hospitalized following two seizures and a gerontologist has indicated that he is likely to require continued institutional care. The secretary noted that Bob has been relocated to Bed 2 in Room 337 of the Queen Elizabeth Hospital and Bob welcomes visitors. Wayne also reported that Hector MacDonald is confined to his residence. Royce Greene reported that Don Kerwin, a former member of the O.P.P. and the RCMP, passed away about two weeks ago.

Nominating Committee Report: The past president reported that the nominating committee, composed of Peter Sorensen and Paul Stetson, completed a survey of potential candidates for executive vacancies in March 2018 and updated it in September 2018 with limited interest from our membership. Incumbents, except the treasurer and secretary, agreed to continue in their current positions for another two-year term. Fred Foster agreed to stand for a two-year term as treasurer and Llew Robinson agreed to serve the last year of the current secretary's term. There were no nominations from the floor so, effective January 1, 2019, the executive will be:

Motion to Amend the Division Procedures Manual: The president proposed a motion to amend the Division Procedures Manual by removing the Immediate Past President as a member of the executive. The secretary provided the text of the motion to the membership on November 1, 2018 in the form of a 'Notice of Motion' and indicated that, if seconded, it would be debated at the November meeting. Derek Smith seconded the motion. The past president addressed the motion and indicated that, in his opinion, it was bad policy and expressed a preference for further study on the issue before voting on the motion. In response to a question about who would chair the nominating committee, the president stated that the executive could appoint the committee. Some members noted that the position is generally used to provide continuity when a new president is elected and the required continuity could be provided

if there was a term limit on the position of past president with a two-year term being considered adequate. The mandatory nature of the position troubled another member who recommended that the position be removed. The president called the question on the motion and it was DEFEATED.

**Entertainment Committee:** Phil Pitts was unable to attend the meeting but he provided a written report that detailed the 2017/18 events and the proposed events for 2019 and invited the membership to suggest other potential events to members of the committee. The secretary provided an oral summary of the report.

**Membership Committee:** Ruby Burns noted that new member Dan D'Amour was in attendance and prospective member Dave Murnaghan was also present. She also stated that she has other prospects in sight. Ruby announced that she is resigning from chairing the membership committee due to the workload involved with being the chair of the Association Advocacy Committee. The president noted the number of new members that have joined the Association during Ruby's tenure and thanked her for her contributions. The president invited the membership to consider volunteering to replace Ruby as the chair of the membership committee.

Advocacy Committee: Scott Ferris noted there have been advocacy-related seminars recently in Amherst and Dartmouth, Nova Scotia. He stated that there is a strong advocacy group in Nova Scotia which has helped over 1,000 members. They have shared some of their documentation with him and he will have it posted on the PEI Division website. He also reported that Veterans Affairs Canada has added 470 new positions in veterans' support to deal with the backlog of cases. Ruby reported having attended the Amherst seminar with Phil and Jeannie Pitts. There were four speakers who all provided useful information. Phil and Ruby are exploring the possibility of bringing part of the seminar to PEI. Derek Smith reported that the criteria for hearing loss claims have been relaxed making claims simpler. He will provide contact information on the subject to the secretary for distribution.

**Military Family Resource Centre:** Richard Thibault invited members to visit the MFRC at HMCS Queen Charlotte and Leona would be pleased to outline the services which they can provide. He also mentioned that the MFRC recently held a successful fundraising event.

**Installation of New Member:** The president installed Dan D'Amour as a member of the Association and he responded with a brief summary of his career.

**AGM in Whitehorse:** The president reported that the Association's 2019 AGM will be held in Whitehorse, Yukon and our constitution provides a grant of \$500 to offset the
