Steve gave a 15-minute presentation regarding the submission of pension claims to VAC and the importance of considering an appeal if a claim is denied. Only about 8% of denied claims are appealed and of those over 90% are approved on appeal. Steve advised there are 150 lawyer advocates and that they are committed to veterans needs and all work hard for the veteran. Steve's message was that Veterans need to be aware that there is help for them if there is a fight with VAC, Don't give up. - appeal, appeal, appeal.

# Seven members had questions:

How do you know if assessment is valid?

A. See us we can help.

Do you have access to Doctor?

A. No, but will pay for specialist if required.

Some veterans not educated and don't know what to do or issue not documented?

A. System is listening now, tell them to see us we can help connect the dots.

How about RCMP A/Csts.?

A. If you have a case, we will fight for you.

Status of RCMP Reservists?

A. Covered by Workers Compensation.
