The Board of Directors delegated the responsibility for the transition to the new Canada Not-for Profit Corporations Act to a Committee of Members, chaired by Director Murray Milne, Saskatoon Division.

Dave Leblanc, Director and Vice President Manitoba Division, Ian Atkins, President Nova Scotia Division, Bob Kells, President, Calgary Division,, Governor Larry Power, Newfoundland Division, and Executive Director, Jack Briscoe are members of the Committee. Our National President Cal Small and our National Secretary Alex Geddes sit as observers.


The Committee has produced a guide for the information of all members of the Association that highlights the key changes that are legislated pursuant to the Act.

A workshop will held on Friday, May 31st, 2013 at the AGM in Saskatoon in order to provide members with an overview of the legislated changes that impact on the future of the Association. Delegates are encouraged to attend this important information session.

On November 1, 2012 I was selected by a 3rd party external review committee to the position of Executive Director of the Association, pursuant to a one year, part-time contract. My mandate is to identify and report to the Board of Directors our strengths, weaknesses and opportunities for improvement, consistent with the legislated requirements of the new Canada Not-For-Profit Corporations Act.

The transitional requirements of the new Act must be completed and filed with Industry Canada by October 17, 2014. Accordingly, my first priority as a working member of the Committee, was to solicit the views and opinions of the membership in a number of key areas of significance. This was successfully accomplished by a survey of all Active and Life Members between February 9 and March 10, 2013.

The results of the survey were very instructive and have been presented to the Board for review. I am very grateful to all Active and Life Members who took the time to complete the survey and provide us with valuable comments.

It is very clear the members who responded see opportunities for improvement in the overall management of the Association and I assure you that the feedback you gave us will be acted upon.

Your present circumstances don't determine where you can go; they merely determine where you start.

WHAT'S HAPPENING IN OTTAWA?

On the Move: The National Office will be relocating from the Nicholson Building to the Canadian Police College (CPC) in the fall 2013. The RCMP will continue to provide office space, equipment and furnishings to the Veterans' Association at no cost.

Enhanced Security Clearance: On February 14, 2013, an MOU was signed between the RCMP Departmental Security Officer (DSO) and the RCMPVA National Office to allow for security cleared access to RCMP facilities in the National Capital Region to conduct Association business for members of the National Executive and the Ottawa Division Executive.

Strategic Alliance with Royal Canadian Legion (RCL) and Veterans' Affairs Canada (VAC). Ron Lewis, our National Advocate is leading an initiative with the Royal Canadian Legion Dominion Command and the RCMP Liaison Officer to Veterans' Affairs to enhance the coordination of services for disability claims for members of the Association.

National Membership Data Base: Director, Bob McKee is developing a national data base of all members of the Association.

Unpaid Second Man: 464 awards have been approved by the Commissioner for presentation. Warmest congratulations to all recipients.

RCMP ID Cards: The process to obtain an official RCMP photo ID card for retired members who have never received the card on retirement was communicated to all Division Presidents. This is not a replacement card. If you have an ID Card signed by a Commissioner when you retired and it is not been lost, stolen or damaged, there is no action required. Issuance of ID cards is an RCMP responsibility. Policy has been amended.

BOARD OF DIRECTORS

The constitution and bylaws of the RCMP Veterans' Association define the distribution of powers between the membership and the officers. Because it is impossible for all members to be involved in everyday administration of the Association, the membership meets at an annual general meeting (AGM) and elects a board of directors to conduct the affairs of the Association between annual general meetings of the membership.

The role of the board is described in the Association's by-laws. So too must the policies and procedures be established and documented. These will differ between organizations, but it is important that all board members be well informed of their expected roles and responsibilities at the beginning of their term.

Our Board, chaired by National President Cal Small, is committed to their leadership role and over the past several weeks opportunities for strengthening the performance of the Board are being examined. As an example, the concept of a consent agenda has been introduced in an effort to improve the effectiveness of Board meetings. The

consent agenda allows the Board to focus their time and energy on matters of strategic importance and priority. New models of governance are also being considered consistent with the legislation so that Board oversight and leadership is distinguished from the day-to-day management of the Association.

Modern, professional governance of the Association is predicated on the legislated requirements of the new Canada Not-For-Profit Corporations Act. All members of the RCMP Veterans' Association should be confident that their elected representatives are committed to serving the best interests of all members of the Association.

Let me introduce the members of the Board of Directors, along with our National Advocate and our Administrative Assistant, Ms. Jennifer Elliot.

Ron was appointed as the National Advocate in October 2012 and he reports to the President of the RCMP National Veteran's Association.

Born and raised in Sydney, N.S., Ron joined the Force in 1969 and served for more than 35 years in "A" Division, "B" Division and Headquarters. His duties included protective, contract detachment, highway patrol, GIS, drug enforcement, drug intelligence, undercover operator, training (HQ T&D and CPC) and the final ten years of service as the HQ SRR.

Ron was instrumental in exposing the RCMP pension and insurance scandal which, after six years (2001/2007) of persistence including the first three years of his retirement, came to a successful conclusion with the intervention of a Parliamentary Hearing and the David Brown Investigative

Inquiry. He is the author of the book entitled "This is Not the RCMP I Joined".

The RCMP Advocacy Program was developed in 2008 within the RCMP Veteran's Association to represent the membership in their dealings with the RCMP, government departments and other organizations in order to facilitate services and benefits available to our membership.

Recent initiatives have taken place which will enhance delivery of services and benefits for our members. For instance, Sgt. Brad Chugg was appointed as the Liaison Officer to Veterans Affairs Canada (VAC) and is located at the VAC HQ Offices in Charlottetown, PEI. In the near future, VAC will dedicate a telephone line for ONLY RCMP members and veterans. The operators will be familiar with RCMP services and benefits. This should solve the present problem of inconsistent responses from VAC to our membership.

Meetings have been held between representatives of our Association and the Royal Canadian Legion (RCL) to foster additional cooperation between our organizations in support of disability claims, services and benefits provided by VAC.

Additionally, steps are being taken to have Advocates in place in every Province to form a national network under the coordination of the National Advocate. Eventually each

Veteran's Association Division should provide a point of contact for members seeking assistance. The network will provide an avenue of support for members and a method to identify systemic barriers.

Communications has been identified as a problem area for many of the services provided to our membership both from our Association and government departments/agencies. Hopefully The Right Marker newsletter will be one of the solutions to enhance our Association communication.

Ron is an active volunteer in five national and international organizations, including President of the Blue Knights International Law Enforcement Motorcycle Club (Ottawa).





Cal was raised in the Newfoundland outport of Jackson's Arm. He joined the RCMP in St. John's, February 1961 and 35 years later after serving in "H" Division, Headquarters Ottawa and "B" Division, retired in St. John's in 1996. Although both Cal and Pat are native Newfoundlanders, they decided to return to Ottawa to be close to their children and grandchildren. A decision that has never been regretted.

At the time of his retirement, Cal joined the Veterans' Association. His first real involvement came in 1988 when he was asked to help solicit sponsors to support the 1999 AGM being hosted by Ottawa Division. It became apparent that in fund raising, effort does not necessarily equal results. Having said that, one company that supported the 1999 AGM still supports us today. It also became clear at that time that a successful AGM requires the talents and efforts of many people.

During his four years or so as Treasurer for Ottawa Division the highlight was his involvement with the Beechwood Project. It was during that time that the idea for the Association to explore the possibility of having a cemetery in Ottawa was first conceived. The Ottawa Division Executive of that day ran with the idea and with the help of some very dedicated and capable people and the assistance of the Force created what is known today as the RCMP National Memorial Cemetery at Beechwood. The RCMP manages this cemetery with the other National Cemeteries across the country. The story behind this great Association project is well documented and is available from Ottawa Division.

Cal was elected to serve at the National Level at the 2005 AGM in Edmonton. He has been fortunate in having a number of challenging and interesting opportunities to serve at this level. He chaired the Board of Trustees and the Editorial Management Board of the Quarterly Magazine, chaired the Financial and Insurance Committee, the Benefits Committee, was a member of the National Operations Committee and served as Vice president. The common denominator in all of this was the opportunity to work with some very bright, dedicated and fine people, actually a privilege to do so.

Cal feels that in the foreseeable future recruiting will continue to be a high priority for the Association. With the many opportunities today to engage in other activities, it is understandable why all retired members do not join. By not doing so, he feels they are missing an opportunity to associate with some very fine Canadians, people they have much in common with. He feels that advocating will continue to be a priority as it provides an opportunity for the Association to provide a worthwhile service to our members as well as those retired from the Force but who are not members of the Association. At this time the Association has no choice but dedicate a huge amount of effort toward complying with the Canada Not-for-profit Corporations Act in order to meet the Oct. 17th, 2014 deadline. There are many other worthwhile projects and activities on the go both at the National and Division levels which he feels bodes well for the future success of the Association.

In June 2012, Jack was appointed to chair a gravesite committee to attempt to locate the graves of the Original 300 (March West) and the Members on the RCMP Honour Roll.

He was born and raised in Toronto and joined the RCMP in March 1960. Following training at 'N' Division (Ottawa) Jack was posted to 'O' Division where he spent his entire career working on small Detachments; a Joint Forces Operation on Organized Crime, then as Section NCO. Jack retired in 1987 then took a position with Canadian Airlines as a Security Manager until January 2001.

He joined the Toronto Division Vet's in 1988 and has served two terms as Vice President and two terms as

President. He has also been the Director of the Sick Committee for the past 20 years.

In 2003, the Toronto Vets entered an agreement with the RCMP to look after the RCMP graves for three Detachment in 'O' Division. This led to a project to locate the graves of deceased members of the NWMP, the RNWMP and the RCMP. Jack learned that an old friend, Joe Healy from Ottawa Vets shared an interest in locating these graves and we decided to collaborate as we were finding members were not necessarily buried in the locality where they passed away. Joe agreed to host a website with a database consisting of the names of members who had passed away and the database now consists of over 22,000 names.

When Jack was asked to chair a graves committee he selected seven other members of the Vets from across Canada to work on this project. These were Vets who had also been researching the location of former member's graves and all agreed to work together and contribute their findings to Joe Healy for his database.

We have had good success on the graves of the Members of the Honour Roll, having accounted for 222 of the 230 names. A number of Honour Roll Members were cremated and we are now trying to locate families to determine the disposition of their ashes. The Original 300 is a chore, as many of the original members served their three years and became history.

In addition to his work on behalf of the Veterans' Association, Jack has kept busy for the past 12 years marshalling at a golf course in Brampton. Jack and Diane live in Brampton, Ontario and have four grown children and three grandchildren.

**TRUE AND FASCINATING CANADIAN HISTORY
1873 - 2013**


